In consideration of the acceptance of my application and the permission to participate as an entrant or competitor in the Muskoka River X Paddling Race and any other Muskoka River X related activities that take place before or after the event. **I, hereby agree as following:**

- 1. In entering into this agreement, I acknowledge that I am aware of the risks, dangers, and hazards associated with canoe/kayak/stand-up paddleboard racing and the unique aspects of this event, and I freely accept and fully assume all such risks, dangers, and hazards and the possibility of personal injury, death, property damager or loss resulting therefrom.
- 2. I have conditioned myself to participate in the event that I have chosen.
- 3. I am a competent paddler in the category that I have chosen to compete in and I am prepared and equipped to be self-sufficient in competing and completing the category that I have chosen.
- 4. I, for myself, my heirs, executors, administrators, successors, and assigns HEREBY RELEASE, WAIVE, AND FOREVER DISCHARGE River X Racing Inc. (race directors), the Huntsville/Lake of Bays Chamber of Commerce, the Town of Huntsville. Township of Lake of Bays, Town of Bracebridge, District of Muskoka, the OMCKRA, and all other associations, land owners, volunteers, sanctioning bodies, event suppliers (services and equipment) and sponsoring companies, and elected and appointed officials, successors and assigns, OF AND FROM ALL claims, demands, damages, costs, expenses, actions and causes of action, whether in law or equity, in respect of death, injury, loss or damage to my person or property HOWSOEVER CAUSED, arising or to arise by reason of my participation in the said event, whether as spectator, participant, competitor, or otherwise, whether prior to, during or subsequent to the event, AND NOTWITHSTANDING that same may have been contributed to or occasioned by the negligence of the aforesaid.
- 5. I FURTHER HEREBYUNDERTAKE TO HOLD AND SAFE HARMLESS AND AGREE TO INDEMNIFY all of the aforesaid from and against any and all liability incurred by any or all of them arising as a result of, or in any way connected with my participation in the said event.
- 6. That this agreement and any rights, duties, and obligations as between the parties to this Agreement shall be governed by and interpreted solely in accordance with the laws of the province of Ontario and no other jurisdiction; and, any litigation involving the parties to this Agreement shall be brought solely within the Province of Ontario and shall be within the exclusive jurisdiction of the Courts of the Province of Ontario.

Further I hereby grant full permission to any and all of the foregoing to use any photography, video tapes, motion pictures, recordings or any other record of this event and my image for promotional purposes: Personal information collected by the organizers is for registration and results purposes only, and may not be shared with other companies or organizations without my consent.
